1. Save the Children in coordination with Department of Education in this region is again holding a summer child participant event "Children's Consultation on Child Rights Monitoring and Leadership Enhancement Training Workshop" from the Province and Division of Sultan Kudarat, South Cotabato and Sarangani on April 29-May 2, 2015 at Mountain Lake Eco Resort, Barangay Bacdulong, Lake Sebu, South Cotabato.

It is expected that the children have the capacity to explain children rights and CRC monitoring process, demonstrate improved leadership skills, understand their role in governance, and create working mechanisms or structure where they can work together as a group.
