This Council Meeting is being held with the purpose of receiving reports and conducting elections as follows:

  - b. To elect Regular Members of the Executive Board to be voted upon the delegates of this Annual Council Meeting;
  - c. To elect the Ten (10) Sectoral Representatives to serve for a term of one (1) year to be voted upon by the newly constituted Executive Board Members.

2. The following are QUALIFIED to make and submit NOMINEES for the Members of the Executive Board:
  - a. Council Officers, Executive Board Members and other Council Members in good standing.
  - b. District Commissioners and Chairperson;
  - c. Institutional Heads/ Principals from Elementary and Secondary Schools (Public & Private)

**3. CRITERIA FOR NOMINEES :**( Members of the Executive Board)

- 3.1 Nominees to the Regular Board Members of the Executive Board
  - a. She/he must be duly registered with the Sarangani Associate Council, BSP
  - b. She/he must have no pending administrative or criminal case in any court or administrative office or must have not placed the Boy Scouts of the Philippines or Council in embarrassing situation or caused damage or harm detrimental to its image or placed the Scouting Movement ridicule.
  - c. He/She must be of good moral standing in the community.
  - d. He/She must be willing to subscribe to and live by the Scout Oath and Law and therefore have not spoken, uttered, and /or expressed derogatory remarks or statements in public and private conversation against the BSP or the Council which is considered detrimental to the best interest of the Movement.
  - e. He/She must be interested in and willing to be trained in Scouting.

- f. He/She must make himself/herself available to serve the Movement.
  - g. He/She must be in good health for the adequate performance of his/her responsibilities and
  - h. He/ She must be aware that the Board Membership means responsibility for quorum and the quality of decisions at meetings.

**3.2 Nominees for Sectoral Representatives**

- a. He/She must be a representative as maybe endorsed and nominated of the sector he represents
- b. He/She must be of good moral standing in the community.
- c. He/She must be young in outlook and identified in the community as an expert in his/her field of endeavor such as government, business, industrial, trade, professional, media, finance, religious, educational, barangay, labor, civic, arts and sciences and other field.
- d. He/She must be interested in and willing to be trained in Scouting and
- e. He/She must make himself/herself available to serve the movement.
- f. He/She must be willing to subscribe to and live by the Scout Oath and Law.
- g. He/She must be in good health for the adequate performance of his/her responsibilities.
- h. He/She must have the ability to motivate others in scouting movement.
- i. He/She must be aware that the Board Membership means responsibility for quorum and the quality of decisions during meeting.

**3.3 REMINDER:** The Nominees for Regular Members of the Board cannot be nominated as Sectoral Representatives in the same way that the nominees for Ten (10) Sectoral Representatives cannot be nominated as Regular Members of the Board on the same election.

- 4. PARTICIPANTS:** The official delegates shall be the following:
- a. Council Officers and Members of the Executive Board;
  - b. District Commissioners and District Chairpersons;
  - c. Institutional Heads/ Principals for Elementary and Secondary Schools (Public & Private) and Rover Circle Managers;
  - d. Deputy District Commissioners provided that will have no voting rights; and
  - e. Secondary School BSP Coordinators/ District BSP Coordinators.

**REQUIREMENTS:** All delegates must be duly registered with the Sarangani Associate Council, BSP.

**ATTIRE:** Official BSP (Type A) Uniform
