Subject : **Training / Retooling for Indigenous Peoples (IP) School Heads and Teachers Batch 2**

1. The Training / Retooling for IP school heads and teachers is being organized to help IP teachers and schools heads develop knowledge, skills and attitudes needed to support the policy directives of DepED Order No. 62, s. 2011 (The National IP Education Policy Framework) and the vision of a culture-responsive and relevant K to 12 curriculum.
2. This two-day training will be conducted on **March 6-7, 2014 at Family Country Hotel, General Santos City.**
3. The Training aims to: (a) develop a holistic perspective on the overall learning and socio cultural context of IP communities; (b) gain and develop a new set of skills related to research, teaching approaches, techniques, and development of learning tools that will help them be effective and efficient teachers /school heads of schools serving IP communities; (c) commit to a conscious effort of engagement aligned with the principles and policy statement outlined in the National IP Education Policy Framework (DEPED Order no. 62,s .2011) through the preparation of a re-entry action plan for SY 2013-2014.
4. The participants to this IP Training shall be coming from the Twelve (12) identified District Supervisors, Twelve (12) District IPed Focal Persons, Four (4) Tribal Leaders, Four (4) Speakers and Five (5) Division Personnel.
5. Each identified District shall send One (1) District IPED Focal Person participant to attend the training, preferably IP School Head assigned in the IP community where the school is located.
6. IP Participants are requested to bring their IP Costumes for documentation and cultural show purposes.
7. The registration fee is free, chargeable against IPed Funds, however, travelling expenses of the participants are chargeable against MOOE / local funds subject to usual accounting and auditing rules and regulations
8. Immediate and wide dissemination of this Memorandum is desired.
